





## AGREEMENT TO PROCESSING PERSONAL DATA

By this document I give free and unconditional consent to the processing by the public organization «International Association for Podology and Foot Care» of my personal data, which will be notified to me personally in any way, in accordance with the Law of Ukraine «On the Protection of Personal Data» with the aim of representing and protecting legal interests of members of a public organization The «International Association for Podology and Foot Care» in the central and local authorities of Ukraine, domestic, foreign and international organizations, as well as for the purpose of sending correspondence by mail and e-mail by the public organization «International Association for Podology and Foot Care».

The public organization «International Association for Podology and Foot Care» has the right to transfer my personal data to third parties for processing in accordance with the specified processing purpose. The public organization «International Association for Podology and Foot Care» has the right to use personal data in accordance with the Law of Ukraine «On the Protection of Personal Data».

In connection with the inclusion of my personal data in a single register of members of the public organization «International Association for Podology and Foot Care», I also confirm that I have been informed about the purpose of collecting data and the people to whom my personal data are transmitted, as well as about my rights according to the law of Ukraine «On the protection of personal data», namely:

- the right to know the location of the unified register of members of the public organization «International Association for Podology and Foot Care», its purpose;
- the right to receive information about the conditions for providing access to personal data, including information about third parties to whom my personal data is transferred, contained in a single register of members of the public organization «International Association for Podology and Foot Care»;
- the right to access your personal data contained in the unified register of members of the public organization «International Association for Podology and Foot Care»;
- the right to receive no later than thirty calendar days from the date of receipt of the request, except as provided by law, an answer about whether my personal data is stored in a single register of members of a public organization «International Association for Podology and Foot Care», as well as receive the content of stored personal data;
- the right to make a reasoned demand with an objection to the processing of personal data by state authorities, local authorities in the exercise of their powers prescribed by law;

- the right to present a reasoned request for a change or destruction of personal data if this data is processed illegally or is unreliable;
- the right to protect their personal data from unlawful processing and accidental loss, destruction, damage due to intentional concealment, failure to provide or untimely provision thereof, as well as to protection from providing information that is unreliable or defaming honor, dignity and business reputation;
- the right to apply for the protection of their personal data rights to state authorities, local authorities, whose powers include the protection of personal data;
- the right to apply legal remedies in case of violation of legislation on the protection of personal data.
